\$0.4750 per share on January 30, 2019;

\$0.4750 per share on April 30, 2019

\$0.4750 per share on July 30, 2019; and

\$0.4750 per share on October 30, 2019.

**15** Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ B&G Foods has determined that of such distributions described above, 7.52443%

(or \$0.142964 per share) will be treated as a taxable dividend and 92.47557% (or \$1.757036 per share) will be treated as a return of capital under Section 301(c)(2). Generally, the portion of the distribution on the common stock that is treated as a return of capital should reduce the tax basis in the shares of common stock up to a holder's adjusted basis in the common stock, with any excess treated as capital gains pursuant to Section 301(c)(3).


